This includes, for example, any expenses related to funding arrangements you entered into in preparation for the Redraw;
- There has been no significant change to my/our ability to repay since the facility was first provided; and if the Redraw is made, I/we will continue to be able to comply with our obligations under the Transaction Documents;
- If you accept this request, the amount of my/our repayments may be recalculated and increased in accordance with my/our Facility Documents;
- If you accept this request, the Redraw will be deposited into the bank account nominated on my/our Direct Debit Request within 24 – 48 hours; and
- For Commercial facilities a redraw fee of \$25 will be debited from the requested amount
- For Residential facilities there are two free of charge redraws per month, any redraws following will have a redraw fee of \$25 debited from the requested amount.
- Redraws completed via Online Portal will not incur a charge.

Words and expressions which are given a special meaning in the Facility Documents have the same meaning when used in this request.

### General Conditions of the Redraw:

- Redraws are only available on loans with a variable interest rate at the time of the redraw and have not been approved for a fixed interest term yet to commence;
- Only loans which are in advance of its scheduled repayments are eligible for redraws; and
- Only cleared funds can be redrawn.

**All borrowers must sign:** *This authorisation is mandatory and must be signed with pen by all borrowers/guarantors. Digital or electronic signatures cannot be accepted.*
